Eppie Griego, Pueblo County Commissioner, reported the jail project is currently working on permits. Pueblo Means Business One Stop Shop is working on remodeling their new office space.

Pueblo Convention Center

Kevin Ortiz, Convention Center General Manager, handed out information about the convention center and Memorial Hall to new commissioners. OVG360 is in year 5 of a 10-year contract. The year is starting out great for both convention center and Memorial Hall.
