MAYOR GRADISAR

Mayor Gradisar asked to address the PURA board. The mayor mentioned the back-and-forth emails between the city attorney, PURA's attorney and executive agenda. The mayor would like to move beyond those emails. PURA is a valued partner to the city of Pueblo. The city and PURA have had tremendous projects together and the city values PURA. Next week the city council will consider two new urban renewal areas. North Elizabeth Hotel and The Bluffs. Both are single site projects. Both projects are specific, and we can track the expenditures. The specific public improvements are not listed, this is a problem. The mayor believes, once the project is completed, the project area should end. Two other URA areas will not be on the upcoming agenda. The mayor believes the plans are lacking specifics. The city can not approve without specifics. PURA can come back to city council after the plans are specific.

Don Banner commented about the TIF seminar he attended in the past and the example of how TIF could be spent in an urban renewal area for public improvements. Development is discouraged by the city.

Ralph William commented that city council approves an urban renewal area, but the city only has 19% of the TIF. It is not logical that the city controls the district. The other taxing entities make up the remaining 81%.

Community Relations

Jeanette Garcia let the board know Community Relations Committee has been meeting with the community Colorado Smelter group. Their goal is to work on lighting and bus stops on Northern. The group is also working on bus tours in the spring and fall for community and public officials. An online request form for donations and events will be on the website for 2024.
