- The board was informed that PURA entered into a contract with Westover Homes to build two stacked duplexes at 612 and 618 E. 2<sup>nd</sup> Street.
- PURA will be at city council for a public hearing on September 9th for the West Pueblo and Colorado Smelter URA project areas. And September 17<sup>th</sup> with the county for West Pueblo URA.
- PURA met with the library district to discuss TIF funding their elevator project.

- PURA should be receiving TIF estimates from the county at the end of August.
- The finance committee will be discussing refinancing the RTA Bonds to bring the interest rates down.
